TO BE COMPLETED BY ALL MEMBERS CONCERNED

- 1.1 The parties to this agreement (“The Partners”) agree to enter into a partnership under the name as set out above (“The Partnership”)
- 1.2 The Partnership shall commence at the date of this Agreement and shall continue until it is terminated as provided in this Agreement.
- 1.3 The Partners shall keep written records of all matters relating to the operation of the partnership including such records as shall demonstrate the account of each Partner in respect of his or her share of the capital & profits of the Partnership.
- 1.4 Any Partner of this partnership will be authorised to sign transfer of ownership forms unless the Royal Pigeon Racing Association is notified in writing, such notification to be signed by all Partners.

2. **TERMINATION**

- 2.1 The partnership may be terminated by any Partner giving to the other(s) not less than 14 days notice in writing in the form specified from time to time by the RPRA. A copy of such notice to be submitted to the RPRA along with the appropriate fee.
- 2.2 Any notice given by any of the Partners shall be served by personal delivery or by pre-paid recorded delivery post to the address of the other Partner(s) as set out in this Agreement or as notified for that purpose from time to time. Any such notice shall be deemed to be effectively served (in the case of pre-paid recorded delivery post) 48 hours after it has been placed in the post.
- 2.3 Upon Termination of the Partnership , the Partners agree that the division of the assets of the Partnership shall be as follows:-

- 2.4 Should any of the Partners dispute the division of assets as set out in clause 2.3 then the divisions of the assets shall be determined by an independent expert, such expert to be appointed by the RPRA. The decision of the expert shall be final and binding on the Partners and the expert’s professional charge shall be borne by the Partners in equal shares.
